Potential Health Effects

Inhalation: Acetic acid produced during cure may irrritate eyes, nose and throat. When heated to temperatures

exceeding 300° F (150° C) in the presence of air, silicones may form formaldehyde vapors.

Formaldehyde is a potential cancer hazard and a known skin and respiratory sensitizer. Vapors irritate the eyes, nose and throat. Safe handling conditions may be maintained by keeping formaldehyde

vapor concentrations below the OSHA permissible limt.

Skin contact: May cause skin irritation.
