## Section 5. Fire-fighting measures

Specific hazards arising from the chemical	: Extremely flammable aerosol. Runoff to sewer may create fire or explosion hazard. 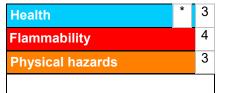
