4. First-Aid Measures

6. Accidental Release Measures

7. Handling and Storage

8. Exposure Controls / Personal Protection

PERSONAL PROTECTION

ENGINEERING CONTROLS: Provide general dilution of local exhaust ventilation in volume and pattern to keep TLV of hazardous ingredients below acceptable limits.
